Od događanja u EU u proteklom razdoblju izdvajamo:

Upitni rezultati češkog predsjedanja Unijom

U neobičnim okolnostima, s tehničkom vladom, nakon što je premijeru Mireku Topoláneku početkom predsjedanja izglasano nepovjerenje, i s izrazito euroskeptičnim predsjednikom Václavom Klausom, Češka je na izmaku svoga polugodišnjeg mandata na čelu Europske unije. Iako je češko Predsjedništvo Vijeća EU-a početkom mandata najavilo da namjerava organizirati **Međuvladine konferencije za pristupanje Hrvatske Europskoj uniji**, radi slovenske blokade hrvatskih pretpristupnih pregovora ta se dobra želja nije uspjela ostvariti. Naime, posljednja je Međuvladina konferencija o pristupanju RH Europskoj uniji održana 19. prosinca 2008., sljedeća je najavljena za 27. ožujka 2009., potom odgođena za 24. travnja 2009., te konačno zbog nastalih okolnosti otkazana. Osim toga, češki je premijer u ostavci bio najavio da će u središtu zanimanja Češke na čelu Predsjedništva Vijeća EU-a biti područje zapadnog Balkana, posebice nefunkcionalna Bosna i Hercegovina, te Srbija, koja zbog nesuradnje sa sudom u Haagu ne napreduje očekivanom dinamikom prema članstvu u EU-u. Izvjesno je da Češka nije postigla očekivan napredak ni u jednom od zacrtanih ciljeva. Od 1. srpnja 2009. **Predsjedanje preuzima Švedska** – ostaje nam se nadati da će ta država članica Unije agilnije i s više žara raditi na rješavanju problema u regiji i posebice pitanja deblokade hrvatskih pregovora s EU-om. Održani izbori za Europski parlament

Od 4. do 7. lipnja 2009. 375 milijuna glasača - građana 27 država članica Europske unije – biralo je 736 predstavnika koji će ih sljedećih pet godina zastupati u Europskom parlamentu. Prvi izravni izbori za Europski parlament održani su prije točno 30 godina, a prije toga, od 1958. do 1979. zastupnike su imenovali nacionalni parlamenti država članica iz redova svojih članova. Slijedom odredaba Ugovora iz Nice broj zastupnika smanjen je sa 785 na 736. Na izbore se odazvalo 43,09% građana s pravom glasa, što je do sada najmanji odaziv, a u skladu s ranijim predviđanjima, najveći je broj zastupnika osvojio blok desnih stranaka, Europska pučka stranka i Europski demokrati (36,3% ili 263 mjesta u Parlamentu), slijede Europski socijalisti (21,6% ili 162 zastupničkih mjesta) te Zajednica liberala i demokrata (11% ili 80 mjesta). Bolje rezultate no na izborima 2004. postigli su Zeleni sa 6,4% glasova tj. 52 osvojena zastupnička mjesta. Veliko je iznenađenje ovih izbora ulazak u Parlament brojnih zastupnika euroskeptičnih stranaka krajnje desnice.

Lisabonski ugovor – ratifikacije se nastavljaju, polako, ali sigurno

Osim Irske čiji su građani na referendumu u lipnju 2008. odbili tekst Ugovora, još bi nekoliko država članica trebalo dovršiti proces ratifikacije i tako službeno pravno omogućiti stupanje na snagu reformskog Lisabonskog ugovora. Iako je Gornji dom češkog Parlamenta 6. svibnja 2009. ratificirao Lisabonski ugovor, predsjednik Klaus izjavio je nakon toga da ga za sada ne namjerava potpisati. Također, i u Njemačkoj i Poljskoj potrebno je dovršiti postupak ratifikacije jer ni tamošnji predsjednici nisu potpisali ratifikacije svojih parlamenta.
