Od događanja u EU u proteklom razdoblju izdvajamo:

Barroso – drugi mandat na čelu Europske komisije

Iako je u lipnju 2009. José Manuel Barroso dobio jednoglasnu potporu šefova država ili vlada 27 članica EU-a za još jedan petogodišnji mandat na mjestu čelnog čovjeka Europske komisije, njegovo je ponovno imenovanje na tu dužnost potaknulo burnu raspravu na rujanskom zasjedanju Europskog parlamenta. Ipak, tajnim glasovanjem zastupnici su potvrdili njegov drugi mandat na mjestu predsjednika Europske komisije. Barroso je izabran s 382 glasa za, 219 protiv i 117 suzdržana glasa.

Hrvatska - Slovenija

Slovenski premijer Pahor i hrvatska premijerka Kosor postigli su 11. rujna 2009. u Ljubljani dogovor oko graničnog spora zbog kojeg je u prosincu 2008. Slovenija bila odlučila blokirati hrvatske pristupne pregovore za članstvo u Europskoj uniji. Presuda Suda EZ-a o internetskim servisima za igre na sreću

Sud pravde EZ-a donio je 8. rujna 2009. odluku kojom potvrđuje da je zabrana koju nameću propisi država članica internetskim operaterima igara na sreću (*online* kladionice) u skladu s pravom Zajednice. Iako Sud potvrđuje svoje prethodne odluke u kojima navodi da zabrane te vrste u načelu predstavljaju **ograničavanje slobode pružanja usluga**, ipak prihvaća **razloge općeg dobra na koje se pozvao Portugal** te portugalske propise proglašava srazmjernima i nužnima za postizanje ciljeva borbe protiv kriminala i prijevara.
