Poštovani čitatelji,

Pred vama je šesti broj biltena *EUROPA info* koji u bibliografskom pregledu obuhvaća reference dokumenata, članaka, studija, izvještaja, sudskih presuda i priopćenja objavljenih u razdoblju od 19. ožujka do 30. lipnja 2010. Nadamo se da ćete pronaći i vama zanimljive nove naslove. Sljedeći broj bit će objavljen u rujnu, nakon ljetne stanke.

U nastavku donosimo kratak osvrt na najvažnije događaje u odnosima **Hrvatske i Europske unije** u proteklom razdoblju:

Nakon višemjesečnih intenzivnih priprema, u Briselu je 30. lipnja 2010. održan deseti **sastanak međuvladine konferencije EU-a i Hrvatske**. Otvorena su tri posljednja skenirana pregovaračka poglavlja – Tržišno natjecanje (poglavlje 8), Pravosuđe i temeljna prava (poglavlje 23) i Vanjska, sigurnosna i obrambena politika (poglavlje 31) čime je učinjen značajan iskorak u procesu približavanja Hrvatske punopravnom članstvu. Osim toga, privremeno su zatvorena dva poglavlja – Javne nabavke (5) i Porezna politika (16), dok je na ministarskoj razini potvrđeno privremeno zatvaranje poglavlja Sloboda kretanja roba (1) i otvaranje poglavlja Ribarstvo (13) i Zaštita okoliša (27). Naglašeno je kako će Europska unija osobitu pozornost posvetiti nadzoru specifičnih pitanja navedenih u zajedničkim stajalištima i na taj način nastojati utjecati na temeljitu provedbu i primjenu *aquis*-a Europske unije. Na svojoj 18. sjednici održanoj 16. lipnja 2010. Hrvatski je sabor usvojio **ustavne promjene** koje među ostalim, omogućuju prilagodbu pravnoj stečevini Europske unije i dovršetak pristupnih pregovora.

Početak lipnja u Sloveniji je održan **referendum** vezan uz **arbitražni sporazum** s Hrvatskom – sa ipak pozitivnim ishodom što je dalo novi vjetar u leđa slovensko-hrvatskim odnosima i omogućilo nastavak napretka Hrvatske prema članstvu u EU. Predsjednik Europske komisije Barroso s odobravanjem je dočekao iskaz slovenskog naroda o tom pitanju smatrajući da je time otvoren put za konačno rješavanje slovensko-hrvatskog graničnog spora.

Tijekom službenog **posjeta Bosni i Hercegovini** sredinom travnja 2010. predsjednik RH Ivo Josipović izrazio je žaljenje zbog zločina počinjenih u BiH u razdoblju od 1992. do 1995., ističući potrebu bliske suradnje svih država i naroda u regiji. Čelnici Europske unije pozitivno su ocijenili istup predsjednika Josipovića navodeći kako se radi o iznimno važnom koraku što doprinosi poboljšanju odnosa ne samo između Hrvatske i BiH, već i među svim državama regije.

### Belgija predsjeda Vijećem EU-a

Belgija je 1. srpnja 2010. od Španjolske preuzela rotirajuće šestomjesečno predsjedanje Vijećem Europske unije u vrlo nezgodnom trenutku s obzirom na nestabilnu političku situaciju u toj zemlji. U svojem programu rada belgijsko predsjedništvo definira glavne ciljeve za pet ključnih područja aktivnosti (ekonomska politika, socijalna politika, zaštita okoliša, sloboda, sigurnost i pravda, te vanjski odnosi) pri čemu kao konkretne ciljeve spominje ostvarenje održivog rasta i realizaciju programa Europa 2020, promicanje socijalne kohezije, okretanje zelenoj ekonomiji, konsolidiranje i dovršenje Europskog prostora slobode, sigurnosti i pravde, te u okviru vanjske politike – jačanje globalne uloge Europske unije kao jamca sigurnosti i mira. ### Lipanski summit Europskog vijeća

Summit Europskog vijeća održan 17. lipnja u Briselu bio je uglavnom posvećen mjerama vezanim uz očuvanje stabilnosti ekonomske i monetarne Unije pogođene svjetskom financijskom krizom. Nije bilo velikih inicijativa poput ranije uspostave fonda od 750 milijarda eura namijenjenih stabilizaciji europske valute. Ipak, usvojena je strategija **EUROPA 2020** što ima za cilj stvaranje novih radnih mjesta i održivog rasta. Zaključke *summita* Europskog vijeća pogledajte [ovdje](#).

### Provedba prava EU-a

Europska je komisija 24. lipnja 2010. pokrenula pravni postupak protiv svih država članica zbog neprovedbe prava Europske unije u raznim područjima. Primjerice, Komisija je od 20 država članica zatražila da u cjelosti provedu odredbe što se odnose na stvaranje jedinstvenog tržišta plina i struje čime bi bila zajamčena nesmetana opskrba i slobodna tržišna utakmica. Također, Komisija je odlučila pred Sudom EU-a pokrenuti postupak protiv 13 država zbog neprovedbe zakonodavstva vezanog uz otvaranje europskog željezničkog tržišta, dok je protiv 12 država članica nastavljen postupak zbog

## Pristupanje EU-a Konvenciji za zaštitu ljudskih prava i temeljnih sloboda

## Eurobarometer o krizi

Studija o učincima krize što ju je u lipnju objavio Eurobarometer otkriva kako svaki šesti euroljanin teško uspijeva platiti režije; tri četvrtine građana smatra kako se siromaštvo u njihovoj zemlji povećalo tijekom protekle godine, a 73 % građana Unije očekuje da će im mirovine biti manje te da će morati raditi znatno duže i štedjeti više za starost. ## Priručnik za kontrolu nogometnih navijačkih skupina

Vijeće je 3. lipnja 2010. usvojilo rezoluciju što se odnosi na ažurirani priručnik s preporukama za međunarodnu policijsku suradnju i mjere prevencije i kontrole nasilja i nemira vezanih uz nogometne utakmice s međunarodnom dimenzijom, a u kojima sudjeluje barem jedna država članica. ## Komunikacijski prioriteti EU-a u 2010.

U dokumentu što ga je 2. lipnja 2010. uputila Coreperu, Radna skupina Vijeća EU-a za informiranje definira zajednička (međuinstitucionalna) prioritetna komunikacijska područja o kojima će tijekom 2010. intenzivno informirati građane EU-a. Identificirana su tri glavna komunikacijska prioriteta: gospodarski oporavak i mobilizacija novih resursa za rast; klimatske promjene i energetika, te naposljetku Lisabonski ugovor i njegova važnost zbog utjecaja na svakodnevni život građana Unije.
